Tier Verification

To ensure the accuracy of placement in member tiers, SPIE may ask company contacts to provide supporting information. All information provided will be kept strictly confidential.

Billing Cycle

Your Corporate Membership is valid when payment is received and processed; fees are paid on an annual basis. Membership fees are non-refundable and non-transferrable.

Exhibiting at SPIE events

SPIE Corporate Member pricing is valid only if the account is in good standing and fees are fully paid prior to submission of exhibition contract and the account remains in good standing through the duration of the contracted exhibition. If the membership expires prior to, or fees are not fully paid at the time of the contracted exhibition, the exhibition pricing reverts to the standard rates and the contracted exhibitor will be liable for the balance due to SPIE.
